SCOPE OF THIS MEMORANDUM OF UNDERSTANDING

1 Introduction

1.1 The University of East London of 4 – 6 University Way, London, E16 2RD (UEL) and B.S. Abdur Rahman University, Vandalur, Chennai 600 048, India (BSAU), hereinafter known separately as a "Party" or together as "the Parties"

- Agree to explore the opportunity of working jointly to:
 1. Cooperate in the exchange of information relating to their activities in teaching and research in the fields of mutual interest;
 2. Promote appropriate joint research programmes and joint courses of study, with particular emphasis on internationally funded projects;
 3. Endeavour to encourage students and staff to spend periods of time at the partner institution. The exchange of students will be dependent upon the execution of a formal Student Exchange Agreement mutually agreed between the parties in writing prior to commencement of this activity;
 4. Conduct research projects, as mutually agreed in writing between the parties, prior to commencement of this activity;
 5. Provide Study Abroad opportunities at undergraduate and graduate level as mutually agreed in writing between the parties prior to the commencement of this activity.

2 Term

- 2.1 This Memorandum commences on the date of its execution by the last to sign of UEL and BSAU and shall remain in force for the period of one (1) year. Either Party can terminate this Memorandum on the provision of at least thirty (30) days written notice to the other Party.

3 Formal Agreement


- 3.1 Any area of collaboration will be the subject of a separate Memorandum of Co-operation, which will address issues including (where appropriate): academic arrangements, legal and financial arrangements, quality assurance arrangements and administrative arrangements.

4 Authority and Legal Status

- 4.1 This Memorandum is only an expression of the current intention of the parties and is not legally binding nor does it give rise to any other rights or obligations.
- 4.2 A person who is not a party to this Memorandum has no rights under the Contract (Rights of Third Parties) Act 1999 to enforce any terms of this Memorandum but this does not affect any right or remedy of a third party which exists or is available apart from that Act.
- 4.3 Nothing in this Memorandum is intended to, or shall be deemed to, establish any partnership or constitute either Party as the agent of the other Party, nor authorise either of the Parties to make or enter into any commitments for or on behalf of the other Party.
- 4.4 The BSAU shall not use UEL's name, logo or branding without the prior written consent of UEL. Similarly UEL shall not use the name, logo or branding of BSAU without written consent of BSAU.
