SCOPE OF THIS MEMORANDUM OF UNDERSTANDING

To promote co-operation in academic and research related activities between Hi-Rise Food Tech Lab, Chennai and B.S. Abdur Rahman University, Chennai, India, hereby agree to enter into this agreement

- 1. The two Institutions shall encourage direct contact between their faculties, administrators, departments, schools and research centres in order to promote this co-operation.
