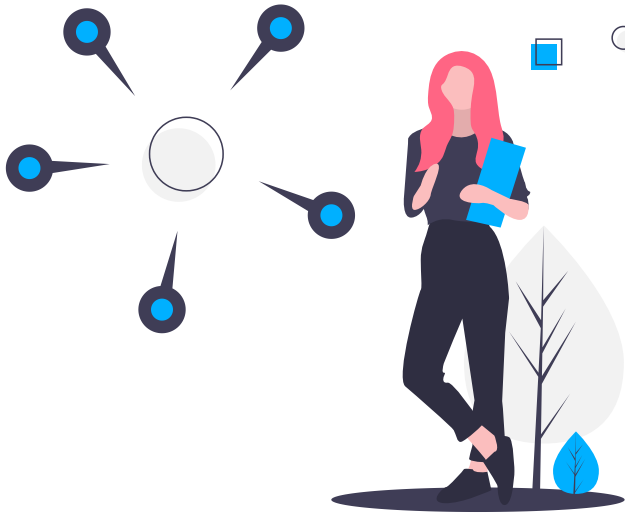
INTRODUCTION:

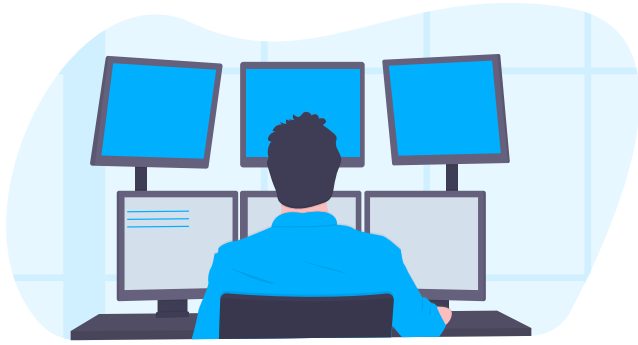
