



**Memorandum of Understanding

Desiring to establish and promote relationships in academic and research field in an institutionalised framework based on both parties' agreement to this Memorandum of Understanding (MoU). The Memorandum of Understanding establishes the following:

**Article I**

**Purpose of the cooperation**

The purpose of the cooperation between International Islamic College Bangkok, Krirk University, Bangkok, Thailand and B S Abdur Rahman Crescent Institute of Science and Technology, Chennai, India is to develop academic collaboration of the two institutions and promote the mutual understanding. Cooperation between the two institutions concerns the interaction and research, academic exchange. The two parties shall conclude programme agreements in order to provide specific cooperation and exchange research projects in specific fields of mutual interests.

## **Article II**

### **Scope: Area and Method of Cooperation**

The area of cooperation includes any program offered by either of the participating parties determined to be desirable and feasible for developing cooperative and productive relations. The methods of cooperation include, subject to the availability of funds and the approval of each institution, research and academic activities or programs such as:

1. Joint Research collaborations and joint publications of research papers in highly ranked peer-reviewed journals resulting from the collaboration within program cooperation.
2. Participation in trainings and workshops for researchers and faculty.
3. Participation in and co-hosting of lectures, meetings, seminars, symposia, and conferences.
4. Exchange scholars, students and research related to information, and publications, within the limits of legal rules and regulations.
5. Joint application for funding of collaborative projects from relevant funding agencies with prior approval of respective institute.
6. Collaboration in other areas that foster research and educational cooperation.

Terms of each activity program, including budget for each program and activity, shall be discussed, and agreed upon in writing by both parties prior to the initiation of the particular program or activity. All terms shall be negotiated on a mutual basis and documented in a project or program agreement. Such joint programs and resulting agreements shall specify the specific responsibilities and obligations of each Party.

**Article III**  
**Intellectual Property**

Procedures for the handling of Intellectual property rights that may arise during the course of this collaboration shall be outlined in a separate document. All terms shall be negotiated on a mutual basis prior to the start of the collaboration project in accordance with the policies of each institution.

**Article IV**  
**Terms of Cooperation**

***Length of Agreement***

This Memorandum of Understanding will remain in force for a period of five years.

***Amendments***

Any amendment to the Memorandum of Understanding will require written approval of each party. After the initial five-year period, this MoU will be renewed by mutual consent.

***Termination***

Either party reserves the right to terminate this MoU upon six months' written notice. Any program or activity that has already commenced shall be completed to the best of both parties' abilities.
