Format:

- Document must be typed in MS Word using Times New Roman, 12-point font size with 1.5 line spacing.
- The total length of the policy document must not exceed 3500 words, excluding references and appendices.

Structure :

- Abstract (not exceeding 200 words)
- Introduction
- Policy Proposal
- Analysis
- Conclusion.
- References.
- Appendices (if applicable)

NOTE:

Originality and Ethical Considerations

- Submissions must be original and should not replicate existing policies. A substantial modification to an existing policy is acceptable if it introduces novel elements or improvements.
- Plagiarism or submission of copied content will result in disqualification.
- Participants are encouraged to consider stakeholder perspectives and include potential strategies for stakeholder engagement.

Awards:

- The best policy proposal will be awarded the "Best Policy" prize.
- The second-best policy proposal will receive the "Runner-Up" prize.
- Prizes and recognition details will be communicated to the winners.
- The decision of the jury is final and binding.
- The jury reserves the right to disqualify entries that do not adhere to the guidelines or are deemed irrelevant or incomplete.
